NOTICE OF FINAL DECISION TO REISSUE A HAZARDOUS WASTE MANAGEMENT PERMIT TO ARNOLD ENGINEERING DEVELOPMENT CENTER

The Tennessee Department of Environment and Conservation's (TDEC) Division of Solid Waste Management (DSWM) has made a final decision to reissue a hazardous waste management permit to Arnold Engineering Development Center (AEDC), located at Arnold Air Force Base, Coffee and Franklin Counties, Tennessee, EPA ID Number: TN8 57 002 4044. The permit was issued on September 30, 2008, and shall remain in effect until September 30, 2018, unless continued, revoked and reissued, or terminated under applicable regulations. This action follows a draft permit issued on July 30, 2008 and a 45-day public comment period, which ended on September 15, 2008. No comments were received from the public during this comment period. However, comments were received from AEDC and are addressed in the Response to Comments.

This permit (TNHW-139) replaces permit TNHW-054 issued to AEDC and allows the facility to continue to store hazardous waste in containers in one storage area with a maximum storage capacity of 57,420 gallons (1,044 drums) in Building 1456. Also included as part of this permit are the corrective action conditions for the solid waste management units (SWMUs) and areas of concern (AOCs). AEDC shall be required to investigate any releases of hazardous waste or hazardous constituents pursuant to this permit at the facility regardless of the time at which waste was placed in a unit and to take appropriate corrective action for any such releases. These conditions also require notification of imminent hazards, and when applicable, compliance with the requirements developed under land disposal restrictions and organic air emission standards.

The permit is reissued under the authority of the Tennessee Hazardous Waste Management Act of 1977, as amended, Tennessee Code Annotated, Section 68-212-101 <u>et seq.</u>, and Rule Chapter 1200-1-11, <u>Hazardous Waste Management</u>. This document has been prepared in accordance with Tennessee Rule 1200-1-11-.07(7)(j).
