NOTICE OF INTENT TO APPROVE A CLOSURE PLAN FOR CONTAINER STORAGE UNITS AT EASTMAN CHEMICAL COMPANY, TENNESSEE OPERATIONS KINGSPORT, TENNESSEE TND 00 337 6928

Eastman Chemical Company, Tennessee Operations (Eastman) submitted a Closure Plan, dated June 5, 2007, to the Tennessee Department of Environment and Conservation's (TDEC's) Division of Solid Waste Management (DSWM) to close three container storage units located on Eastman Road in Kingsport, Sullivan County, Tennessee 37662. The [Eastman facility](#) is located approximately 2 miles north on John B. Dennis Highway (State Highway 93) from US Interstate 26. This notice is in accordance with Rule 1200-1-11-.05(7)(c)4(iv).

Eastman is a privately owned facility that manufactures chemicals, fibers and plastics. It is composed of manufacturing areas including power and generation, water supply and maintenance, industrial landfills, a wastewater treatment plant, and buildings that provide administrative, engineering, research, sales, environmental, health and security, etc.

The Closure Plan describes the activities to close three storage units, designated by EPA as HWSU-18, 19 and 20, as required under Rule 1200-1-11-.05(7). These three units are located at Eastman's incineration complex and have never been used to receive waste from offsite; nor have they been used to hold waste for more than 90 days. However, these units were included in Eastman's original RCRA Part A submittal in 1981. Since the original RCRA Part A was filed, Eastman has removed them from subsequent applications and has never applied for a RCRA Part B permit for these units. Eastman has maintained financial assurance for the units because of the original RCRA Part A application.

After considering all public comments received, the DSWM will determine to approve the closure plan with or without modification.
