

NOTICE OF A PUBLIC MEETING TO MODIFY EXISTING HAZARDOUS WASTE MANAGEMENT FACILITY PERMIT

EnergySolutions, LLC, and Duratek Services Inc has requested that the Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) modify the existing Hazardous Waste storage permit at their Bear Creek Facility located in Roane County Tennessee. The modification request includes deletion of commercial management of non-mixed wastes (radioactive and RCRA) and the addition of hazardous mixed waste treatment and storage in another building at the site.

The EnergySolutions/Duratek Services Inc. facility, permit No.TNHW-129, EPA identification number: TND 98 215 7570, is located at 1560 Bear Creek Road, Oak Ridge, TN 37830. The official representative for operation of the facility is Mr. Troy Eshleman, Vice President of Commercial Processing; phone: (865) 481-0222.

As per Tennessee Rule 1200-1-11-.07(9)(c)5(iii)(IV), **a public meeting shall be conducted** to answer questions or comments posed by the public regarding the permit modifications. The meeting shall be held on Wednesday, September 12th, 2007 at 7:00 p.m. eastern time (EDT) at the DOE-Oversight Office, located at 761 Emory Valley Road, Oak Ridge, TN 37830.

As per Tennessee Rule 1200-1-11-.07(9)(c)5(iii)(II), **a 60 day comment period** shall be established to give the public the opportunity to submit written comments regarding the permit modifications. The public may submit comments to: Ms. Angela Ivory, Treatment, Storage, and Disposal Section Division of Solid Waste Management, 5th Floor L&C Tower, 401 Church Street, Nashville, Tennessee 37243-1535. **Comments must be received by 4:30 pm CDT on Tuesday October 2, 2007, to assure consideration.** After considering all public comments, the DSWM Director will issue a final permit decision and a Response to comments, which can be viewed at the Oak Ridge Public Library or at the TDEC Central Office in Nashville.
