WATERSHED DESCRIPTION: Lower French Broad Watershed (HUC 06010107). West Prong Little Pigeon River. Approximately 8.1 miles of the West Prong in Sevier County is on the 303 (d) list. Subject property is vacant land. Surrounding land use is widely scattered open field, woodlots and residential/commercial to the north and heavy commercial to the south. Subject wetland is dominated by herbaceous plant communities. The affected watershed has been determined to be Tier 1.

PROJECT DESCRIPTION: The applicant proposes to construct a commercial development known as West Terrace on a 37-acre tract at the above location. The proposed development is \$24 million, 93,000 square-foot of retail space, restaurants and associated infrastructure. The proposed project will require the placement of fill in 0.23 acres of the 0.57 acres of jurisdictional wetland that are identified onsite.

Borrow material will be obtained from the tract of land located to the north.

Compensatory wetland mitigation will consist of the purchase/debit of 0.46 credits/acres from the Indian Creek Wetland Mitigation Site in Roane County.

In addition, the applicant proposes to utilize pervious pavement in the parking and vehicular traffic areas.

The division will conduct a public Hearing on this and three other projects proposed in this vicinity in Pigeon Forge. The Hearing will be held on Thursday, June 28, 2007 at 6:00 P.M. EDT in the Council Meeting Room of the City Complex of Pigeon Forge, 225 Pine Mountain Road, Pigeon Forge; (865) 429-7474. A separate notice for the Public Hearing is included in this notice.

the record and will be considered in the final decision. The applicant's name and permit number should be referenced.






