LOCATION: Near the intersection of South Willow Avenue and Humble Drive on the west side of South Willow; Cookeville, Putnam County.

WATERSHED DESCRIPTION: Caney Fork River Watershed (HUC 05130108). Surrounding land use is primarily commercial. An unnamed intermittent stream occurs on the property with three small wetland areas. Surface flow is confined entirely on the subject property in a one foot wide and two foot deep channel. It originates at a seep from wetland #3 (0.03 acres) and wetland #2 (0.03 acres) and flows 337 linear feet to wetland #1 (0.01 acres). The wetlands are dominated by cattail.

PROJECT DESCRIPTION: The applicant is proposing a commercial development that will require the placement of fill over 337 linear feet of an unnamed stream. In addition, the applicant will obtain a General Permit for Minor Alterations to Wetlands.

Compensatory stream mitigation shall occur with the payment of \$200.00/ linear foot or \$57,400 to the Tennessee Stream Mitigation Program.


No decision has been made whether to issue or deny this permit. Persons wishing to comment on the proposal are invited to submit written comments to the department. Written comments must be received within **thirty days of the date that this notice is posted**. Comments will become part of the record and will be considered in the final decision. The applicant's name and permit number should be referenced.

Interested persons may also request in writing that the department hold a public hearing on this application. The request must be filed within the comment period, indicate the interest of the person requesting it, the reasons that the hearing is warranted, and the water quality issues being raised. When there is sufficient public interest in water quality issues, the department will hold a public hearing.


