**LOCATION:** South of Interstate 40 and east of Canada Road, Lakeland, Shelby County.

**WATERSHED DESCRIPTION**: Wolf River Watershed (HUC 08010210). Unnamed tributary to Grays Creek (?). Surrounding land use is commercial to the north, east and west and woods to the south. The unnamed tributary to be impacted is a Tier 1 stream.

**PROJECT DESCRIPTION:** The proposed project involves the construction of a mixed-use residential and commercial development on a 127.30 parcel of which 86.77 acres will be developed. The applicant proposes to create three small lakes that will impact 970 linear feet of the 1,130 linear feet of the unnamed tributary. The stream has a bottom width of three feet and top of bank width of approximately 15-feet.

The 1.365 acres of wetlands and 2400 linear feet of remaining stream on the southern portion of the property will be preserved with the natural area that the developer has set aside as part of the development.

Compensation for impacts to 970 feet will be through a payment of \$200/ foot to the Tennessee Stream Mitigation Program.



The request must be filed within the comment period, indicate the interest of the person requesting it, the reasons that the hearing is warranted, and the water quality issues being raised. When there is sufficient public interest in water quality issues, the department will hold a public hearing.






