LOCATION: unnamed tributaries to Drakes Creek, east side of Anderson Road in Hendersonville, Sumner County, 36.3625°N/86.58027°W

WATERSHED DESCRIPTION: Cumberland – Old Hickory Lake watershed. Streams vary from 3 feet wide to 15 feet wide with substrate varying from bedrock to earthen. Stream flow is characterized with some areas of flow, isolated pools and many dry runs. Tier 1 water.

PROJECT DESCRIPTION: The purpose of the proposed activities is to facilitate the development of the Fountain Brooke Subdvision Phase 1 Section 2 located in Hendersonville, Tennessee by providing roads, utilities and storm water detention.. The impacts are as follows (see plan views for stream identification):

Watercourse 1: gravity sewer crossing

Watercourse 2: road crossing consisting of 94 feet of 42-inch RCP (sunk), relocation of approximately 90 feet, gravity sewer crossing and a walk bridge crossing. The relocated stream channel will mimic existing channel dimensions (approximately 4 to 6 feet wide) and have 3:1 side slopes. The stream will have a minimum 25 foot buffer but that will extend to 50 feet and beyond in some places. Native woody and herbaceous species will be used.


Watercourse 4: Watercourse 4 has been determined to be a wet weather conveyance. It is upstream (and connected to) of watercourse 1. The applicant proposes in-line detention.

Previous ARAP authorizations for this site include NRS06.251.


In accordance with the Tennessee Antidegradation Statement (Rule 1200-4-3-.06), the division has determined that the proposed activity will not result in degradation to water quality.

USGS TOPOGRAPHIC QUADRANGLE: Hendersonville Quad (310-SE)


Topographic Map




Hydrologic Determination




Plan View
