LOCATION: Unnamed Tributary to Garrison Branch, near Monterey Putnam County lat36.16048/long85.22793

**WATERSHED DESCRIPTION:** The unnamed tributary flows south along State Route 164, passing under the existing railroad bed to its confluence with Garrison Branch. The tributary is a narrow and shallow tributary that flows into a culvert and empties into an impoundment south of the railroad bed. The riparian vegetation is primarily mature trees and herbaceous. The area is rural agricultural.

**PROJECT DESCRIPTION:** The applicant proposes to relocate approximately 905 feet of the tributary into a constructed channel. The relocation would involve diverting the stream from the current culvert and impoundment, which would be left in place for use as a settling pond for the Monterey Sand Company (property owner) once the existing culvert is abandoned and the stream relocated. The new channel would parallel the existing railroad bed for 734 feet to Waterview Drive were it would be encapsulated in a 30" corrugated metal pipe for a distance of 170 feet to pass beneath both the road and the existing railroad bed and rejoined with its original bed south of the railroad. The relocated channel would be trapezoidal with 2:1 sloped stream banks. Riprap would be used on the side slope of the railroad bed to prevent scour. There would be a net gain of approximately 210 feet of stream length with the relocation.

In accordance with the Tennessee Antidegradation Statement (Rule 1200-4-3-.06), the division has determined that the proposed activity will not result in degradation to water quality.

When there is sufficient public interest in water quality issues, the department will hold a public hearing.
