WATERSHED DESCRIPTION: HUC 06040003, The Duck River is assessed as High Quality Tier 2 from Duck River embayment to Bear Creek, Humphreys and Maury Counties. The stream segment that would be affected is **ID TN06040003026_1000** TN Duck River and is listed as fully supporting.

PROJECT DESCRIPTION: The proposal involves the re-issuance of the permit that would re-authorize the ongoing withdrawal of water for domestic water supply. The present permit authorizes the withdrawal water from the river at a maximum rate of 31 cubic feet per second. The permit requires the maintenance of at least 100 cubic feet per second flow in the Duck River.

In accordance with the Tennessee Anti-degradation Statement (Rule 1200-4-3-.06), the division has determined that the proposed activity may result in degradation to water quality.

No decision has been made whether to issue or deny this permit. The purpose of this notice is to inform interested parties of this permit application and to ask for comments and information necessary to determine possible impacts to water quality. Persons wishing to comment on the proposal are invited to submit written comments to the department. Written comments must be received within **thirty days of the date that this notice is posted**. Comments will become part of the record and will be considered in the final decision. The applicant's name and permit number should be referenced.

Interested persons may also request in writing that the department hold a public hearing on this application. The request must be filed within the comment period, indicate the interest of the person requesting it, the reasons that the hearing is warranted, and the water quality issues being raised. When there is sufficient public interest in water quality issues, the department will hold a public hearing.

The department shall consider practicable alternatives to the alteration. The department shall also consider loss of waters or habitat, diminishment in biological diversity, cumulative or secondary impacts to the water resource, and adverse impact to unique, high quality, or impaired waters.
