WATERSHED DESCRIPTION: The proposed impacts would affect a Third Creek and unnamed tributaries to Third Creek. Third Creek is a perennial stream having a wide channel ~10 - 15 feet wide with 1 to 2 foot high banks. The stream varies in depth up to 8 inches flowing over a boulder/gravel substrate and has a canopy of hardwoods and shrubs (mainly Chinese privet). The land use in the area is suburban residential. Department records indicate that a 2004 TDEC biological survey of Third Creek at mile 1.0 (Tyson Park Foot bridge) 2 EPT genera and 20 total genera (Index score = 14) wer found. The stream failed biocriteria (Habitat score = 135). Three E. coli samples out of twelve were found and a water contact advisory for pathogens was issued.

PROJECT DESCRIPTION: The project would involve the replacement of the existing culvert at Station 158+81+/- with 94 ft. of 2 @ 14 ft. X 8 ft. box culvert plus riprap along the wing walls for stabilization. Associated with this activity is the proposed installation of two sewer lines at Sta. 159+10+/- (Rt.) and (Lt.), the replacement of an 8" gas line at Sta. 158+81+/-, and replacement of a water line at Sta. 158+81+/-
