

- 1. Reservations are not transferrable.
- 2. Hunters may only hunt with the party with which they are drawn.
- 3. Hunters may only hunt the pool and dates for which the party is drawn.
- 4. Hunters may not switch pools.

2007 BOGOTA INSTRUCTIONS

- You must apply at a TWRA license agent, at any TWRA regional office, or online at www.tnwildlife.org. If you encounter any problems while applying, please call **615-781-6621** during regular office hours (8:00 a.m. 4:30 p.m. CST). Do not mail this instruction sheet to TWRA.
- You may begin applying September 18, 2007. The deadline is midnight, October 17, 2007.
- No person may apply more than once. If two or more applications are submitted representing one individual, that individual's application will be **rejected** and the individual will be **subject to prosecution.**
- A party must be established by a party leader who will **create** the party and select the hunt choices for the party. The party leader will also decide whether or not to allow an applicant with lower priority to join his/her party. A party number will be assigned to the leader, and anyone wishing to **join** the party must have that party number when applying. A **party may not exceed 4 members.**
- Party numbers are assigned once the application is processed and are printed on the receipt.
- Youths, ages 6-16 by the date of the hunt, may apply. However, they must apply and hunt in a party with at least one adult, 21 years of age or older, who must remain in a position to take immediate control of the hunting device.
- Applicants must review their application receipt and verify name, address, hunt locations, fees, etc., upon completion to ensure accuracy. If joining a party, you must verify the party number.
- No edits will be made to the applications after the deadline.
- You have up to 12 choices but you will be eligible for only one permit. Do not use the same hunt code more than once.

WHEN APPLYING AT A LICENSE AGENT:

- You may apply at any TWRA license agent. There is no fee for current Annual Sportsman or Lifetime Sportsman License holders or senior citizens possessing a Type 167 permit. For all other applicants, there is a \$10.00 nonrefundable permit fee plus a \$1.00 agent fee.
- You will need to provide the license agent with your date of birth and one of the following: your Tennessee driver's license, your TWRA ID number, or your Social Security number. **If applying alone** or **creating** a party you need to know your hunt choices and how many drawings you wish to enter. If **joining** a party you will need to know the party number (which should be obtained from the party leader before applying).
- When applying in person, you must remain until your application is processed to verify that the information is correct and to receive your receipt with your confirmation number.

WHEN APPLYING ON THE INTERNET:

- There is no fee for current Annual Sportsman or Lifetime Sportsman License holders or seniors possessing a Type 167 permit. All other applicants will be charged a nonrefundable permit fee of \$10.00, plus \$2.50 internet usage fee. This is a fee collected by the company who maintains the internet site, not a fee charged by TWRA.
- Go to www.tnwildlife.org. Click on "Online Licensing" on the left side of TWRA's home page. The next page will say "Online License Center." Scroll down to the bottom and click on "Start."

BOGOTA DRAW INFORMATION:

- 1. A computer drawing will be held to determine successful applications based on the Priority Drawing System.
- 2. **Priority Drawing System:** TWRA's Priority Drawing System gives priority points (maximum of 2) to hunters based on the number of years they have participated without being drawn for a hunt. Applicants who were successful last year will have a priority of zero. In order to be drawn with priority, applicants **must** apply either (a) alone; or (b) in a party in which **all** applicants have priority. If a party includes a member who does not have priority, that party (and all its members) will be drawn at the lowest priority of the application.
- 3. Drawing Procedures: Using the "luck of the draw" method, an applicant or party of applicants is randomly selected by the computer. The party's first hunt choice is compared to the vacancies that may exist for that hunt, and if there is a vacancy, they are assigned that hunt. If not, the second choice, etc. (in order), are examined until the party is assigned a hunt, or runs out of hunt choices.
- 4. Reservation cards will be issued to successful applicants. Successful applicants must possess all the appropriate licenses and permits to hunt. The reservation holder has exclusive access to pool and dates he/she is awarded. Any pool where the reservation holder is absent shall remain vacant for that date.
- 5. **Reservations are nontransferable.** Any person violating this rule and regulation is subject to having his/her reservation and /or hunting privileges revoked and may be subject to prosecution.
- 6. Only those whose names appear on the computer drawn application will be allowed to participate in the hunt. There will be no sign-ons or add-ons after the draw. If only one hunter appears on the application, that hunter will be the only person that will receive a reservation permit.

2007 BOGOTA RESERVATION INFORMATION

- Hunters may access the hunt pools only on the days indicated on their hunt reservation.
- Hunt pools are walk-in, temporary blinds only. Small non-motorized boats may be used.
- Hunters may **not** switch pools. The reservation holder has exclusive access to pool and dates he/she is awarded. Any pool where the reservation holder is absent shall remain vacant for that date.
- Hunters will be allowed to leave decoys and materials out during their 3-day hunt, but must remove them at the completion of the hunt.
- Check in or out is not required. However, hunters are encouraged to complete a harvest survey upon completion of the hunt.
- All hunting ceases at 3:00 p.m. daily.
- All vehicles are required to stay on the gravel roads. No vehicles are allowed in the fields or on dirt levees.
- Each hunting pool will have designated vehicle access for unloading equipment.
- Parking areas for each pool are within walking distance but are located far enough away that they will not disturb the hunting areas.
- All vehicles are required to park in the designated parking areas only.
- Hunters violating any of the rules or regulations are subject to the revocation of their permit.
